Volunteer Opportunity

Volunteering in a correctional setting

We have the following volunteer opportunities in corrections settings. MEC volunteers should review the MEC statement of faith and qualifications for volunteers on the basic resource pamphlet, call for a phone conversation to determine if it is a good fit and if you want to proceed a phone interview would take place then or be scheduled for a time that works for both of us. An individual can and fill out an application from the website either before or after the phone interview. An application indicates to us that you want to proceed and if this and the phone interview indicates proceeding, we will check references and invite you to an MEC orientation where you will learn more about the ministry and the expectations.

- **Re-entry – meeting one to one and providing resources and helping set goals to prevent recidivism**
- **Woman's Bible Study**
