## Problem Thinking and the Lord's Healing Ownership

The concept of ownership stretches our thinking because it can exist without the person thinking that they are acting as though they own another person or their possession(s). It is most obvious in crime, such as theft. When a thief enters



the premise anything in sight is presumed to belong to him or her. In less obvious ways it is present in relationships. Control is valued more than the other individual or relationship, but the controller is not aware of it. The thinking is so engrained that it is not done with malice. Anger arises when the person who believes they or their rights are more important than others are crossed.



We can see this when a person complies or cooperates as long as it is their idea or decision to do so. Money can be expected to be supplied by others. For example, a bully may take another's money under threats or an employer is expected to pay more than he or she does without the employee

understanding what the employers compacity is. An employer who feels ownership would feel that the employees pay obligates them to servitude more than it does. The employee may feel that the employer is fortunate to have him and tries to set his own pace and schedule, often directing others. Conning, disruption, coercion, cheating, intimidation, may be overt or covert and cause confusion. The server with ownership thinking may be very cooperative currently, with plans or belief that to take ownership will be theirs in the future.

For those who feel ownership in the sexual area, they feel irresistible and a game of moving in to woo, conquer or obtain what is already theirs ensues. The responsible party in the relationship is expected to be ever faithful, while indiscretions of the owner are

## **MEC Spotlight**

Our spotlight this month is on the inmates and prayer. The stories vary greatly of who the volunteers work with. It could be someone who said something they wish they had not said to planned murder. The time could be only in for a few days and they only come to Church, Bible Study or a Recovery class one time. They are usually waiting for court and could have to go one time or several times. They could be getting out soon to a relatively stable home or they could be in for a close to over a year. They could need treatment or mental health services. They could be in under false accusations or events that they have no memory of.

For our volunteers alone there are 18 facilities which range from 65 to 650 or more inmates. We only cover a portion of the state(s).

With the prayer requests that are turned in, our prayer letter goes out every 10 days and it is often 8-10 pages long with 20-30 requests per page.

Here are a few of the prayer requests. The names have been changed as confidentiality is required. Pray for them with us and as you do, let God stir your heart to pray for the corrections in your community.

They are not far down the road from you.

Correctional officers who deal with difficult people and inmates who are in difficult circumstances need hearts to be softened and that God's people care.



Families of inmates, sheriffs, emergency call workers, police officers., parole or probation officers —who are now called supervising agents all face challenges that many of us may or may not face.



One idea that helps to cement these in our hearts is to ask, what is the promise in this verse and what is the way to obtain that promise. Here is a link that breaks down the first two chapters in this way. Be encouraged to study through each chapter asking these questions.

The change process should be uncompromising and involves several thought changes. I have taken some of the thoughts from Yorkelson and Samenow, added my reactions and supplied verses which have informed this conversation.

 Cont. on pg. 3 PTLH friend a year ago and she went off the deep end falling further into drugs. She couldn't see the sense in a beautiful 23-year-old girl dying way before her time. She no longer calls herself a victim even though she had a very rough life grow-

ing up with a mother who only had children so they could be her slaves and do her bidding while she sat on the couch and drank and went out. They were abused, mistreated, and neglected. For many years Lizzie thought of herself as a victim, that she always got the bad end of the deal. God has shown her that He made

her strong to withstand it all and now He has a plan for her life. She had such peace and spoke of God with such love. She came to jail with a gram of heroin in her system that should have killed her, but ...God saved her. She is very thankful and grateful to be in jail to begin to get her life in

order. Then she met with a public defender, he asked her about some circumstances and showed her a picture and asked if it was her since it didn't look like her when she was heavy on drugs. She admitted it was her, and the public defender was shocked she would admit



that and he could tell from her eyes, that she had a new spirit about her. He told her if she needed any help in the future, to let him know. In [these] ways...God is showing Himself to her. Her court date is on March 1st.



**Jessica** - for the health of my baby with my pregnancy, that I am out before the baby is born and that I can finish treatment and be back with my 10 year old.

Lesly Keaton & Lisa Kelly (volunteers) - We had a total of

seven ladies today. The oldest is 33 years old, and two (at least) are pregnant. Our focus was on Principal 6, which discusses making amends, forgiveness (to others and ourselves) and God's grace.
