I came to know Jesus through the struggle of addiction to opiates and methamphetamines and jail, by actively wanting something different in my life.

I knew of God as a little girl but didn't know He was asking me to have a relationship with His son Jesus. I gave my life to Jesus in Washington County Jail in 2016 after reading a handout about the cross. I said the prayer to receive Christ as my personal Lord and Savior November 2016 after listening to someone in jail church talk to me about what John 3:16 really meant.

Christ filled me with His Holy Spirit and began a good work in me, giving me the desire to read His Word and to change my lifestyle. I began reading in jail, learning scripture, asking questions and establishing a relationship with Christ. The Lord led me to Philippians 4:13 instilling in me Christ's strength and reminding me that without him I can do nothing. The Holy Spirit then led me to do a Bible study in jail called the Key to Your Expected End by Katie Souza where I found true passion in Jesus when God spoke-

Covid Update

Greetings MEC Friends!

As you know, currently the jails have shut down all volunteers or visitors from going into the jails to but we are still

operating. Some of the volunteers are providing lessons for inmates by e-mail, we are sending books and workbooks for the inmates to have materials to work on, and we are asking for you to pray. Please read through to this whole letter for some important information on how to do so. In select cases the volunteers are able to do video or minister over the phone. Pray that this would be available to more volunteers and inmates.

Some counties have many inmates, and some have very few inmates. Some of the older inmates who are not considered a threat and who are more vulnerable to the virus have received compassionate release.

For some of the counties who have the inmate's names on the websites, volunteers took names to



praying over the inmates and staff. Some are taking a dozen names others are taking a day a week of the roster. The two jails that have had more specific prayer are taking lessons so that twenty eight of the services per week are being covered by e-mail. This shows us how important the prayer is and if you could commit to praying for your county that would be appreciated. The largest one is asking for activities that they can do while they are in their cells. Being in these small cells for hours is very very challenging to mental health.

If you are willing to take names to pray for, willing to send a letter or a postcard encouraging an inmate to be praying and seeking

We get calls from family members and letters that we are responding to pray and to send resource information for spiritual growth, encouragement and support such as Teen Challenge or other faith based programs. Teen Challenge is open and taking clients. Their gala is online this Friday evening May 1st, and promises to be inspiring with testimonies and music Saul has a lot of responsibility there keeping precautions and care going for both staff and clients.

We have done one Zoom video orientation for 3 volunteers and are hoping when this is ended the current volunteers can resume and new ones can get cleared and start.

Please pray for Sandy, although she does not have COVID we are praying for her life, for health and healing, for her to come back to us, for the Holy Spirit to fill her. If you are willing to fast and pray, please do so.

Nadine is able to do a little from home.

May things from the office that have been in the "please get to this when you can" areas are now being concentrated on.

I thank God for you, for God providing members of His family that I am able to call and pray with to release the pressures that build up. For many at this time ideas and issues we have covered up with activity are surfacing and it is good to know that He heals and He holds all things together. As Peggy reminded me in her prayer this morning, He gives us what we need to persevere and that He supplies grace upon grace.
