- **E** Pray that I can find hope and the desire to stay on the right path as I get distracted easily here. Also, that I find positive friends and people to be around.

- **M.** shared the Lord had blessed him in his legal issues by working out his release. He was all smiles, praising God the whole night.
- **N.** is trying to get a 1st degree murder charge reduced to 2nd or 3rd so that he could get into a christain treatment center. More about this in the confidential prayer requests for intercessors
- **J.** actually was the first one in for that service, well before the other men. Early on, however he had an outburst, swearing and proclaiming that God was not reliable, etc. He was very distressed. There was an audible, negative reaction from the other inmates. [We] offered to pray with him right then, which was accepted. We also offered to pray with him after the service. We continued with the service, but J left early. He did ask for prayer for health issues in his family, as well as his own issues.



There are many requests for releases, court days, family members, forgiveness & reconciliation. These are what we all long for in many ways. How much more is this true for those coming to seek God while they are in jail?
